

Through this fundraiser, we hope to help raise the much-needed funds for the beneficiaries under our services, who are mostly from low-income families.

All donations are eligible for 250% tax deduction.



After a stroke, Mdm Zaina lost the ability to move, sit or even recognise her loved ones.

She was transferred to SLH for post-stroke rehabilitation to improve her strength, balance and mobility.

Staying alone in a one-room rental flat, she was most worried about coping at home post-discharge.

Our social workers explored options and care plans with Mdm Zaina's two sons, allowing her to focus fully on her recovery. Financial support and grants were also applied to ease their financial burden in the journey ahead.

With determination, she slowly regains her independence – being able to walk short distances and enjoying a stroll at the community garden. She looks forward to full independence by continuing with therapy at the Day Rehabilitation Centre.
